



**MobileView® Software Platform  
Terms and Conditions**

Effective: May 1, 2023

The following terms and conditions apply if Client (“**Licensee**”) purchases a license to Seller’s (“**Licensor**”) MobileView Software Platform or associated Hardware. Unless specified otherwise within these terms and conditions, all capitalized terms used in these terms and conditions shall have the same meaning as they do in the Agreement.

1. Usage Parameters. In addition to all other usage conditions and/or restrictions specified in the Agreement, the following Usage Parameters shall apply to Licensee’s Software license:
  - a. Perpetual Software Usage Parameters: Licensee may use the Software for the licensed Use Case at the facility listed in the Ordering Document to communicate with an aggregate number of tags equal to the number of licenses for the Software purchased and paid for by Licensee (each a “**Tracked Unit**”, and collectively the “**Tracked Units**”).
  - b. Enterprise Software Licenses Usage Parameters; License Fee. Except as expressly set forth in an Ordering Document:
    - i. Hugs® Infant Protection Use Case Only. Where Licensee purchases and pays for an Enterprise Software license to Licensor’s MobileView Software for the Hugs Infant Protection Use Case only: (i) Licensee may use the Enterprise Software with an unlimited number Tracked Units at the Permitted Facility(ies); and (ii) the initial License Fee for the Enterprise Software at the Permitted Facilities shall be the License Fee stated in the Ordering Document. Additional fees, including without limitation License Fees, shall apply if Licensee desires to add additional Permitted Facilities and/or licensed Use Cases.
    - ii. All Other Use Cases: Where Licensee purchases an Enterprise Software license for Licensor’s MobileView Software for any other Use Case(s) (including without limitation the Hugs Infant Protection Use Case with one or more other Use Cases): (i) Licensee may use the Enterprise Software with an unlimited number of Tracked Units at the Permitted Facilities; and (ii) the initial License Fee for the Enterprise Software at the Permitted Facility(ies) for the licensed Use Cases and the Initial Bed Count shall be stated in the Ordering Document. Licensee shall notify Licensor if Licensee adds any additional beds at a Permitted Facility. Licensee shall pay Licensor’s then-current license fee for each additional bed above the Initial Bed Count.
2. Seller Not Responsible for Licensee’s Network. Certain Hardware uses and relies upon Licensee’s Wi-Fi network to enable the Hardware to transmit and/or receive communications. In a location where there is interference with, or Licensee’s Wi-Fi network is insufficient to connect to or successfully transmit and receive data, the functionality of the Hardware may be impaired or not work properly. Securitas Healthcare shall not be responsible for, and specifically disclaims any and all responsibility and liability for any impairment or improper functionality associated with or resulting from interference with or insufficiency of Licensee’s Wi-Fi network.
